1. The Sub-Collector, Kendrapara-cum-Chairman, RMC, Kendrapara invites **percentage rate bids in Single Bid for Sl. No.1 to 3 and Double cover system (Cover-I: TECHNICAL BID & Cover-II:- PRICE BID) in online mode** for the work in the table Sl. No.4 to 6 from **the eligible contractors having experience in similar nature of work** registered in "D", "C", "B", "A" & "Special" with Govt. of Odisha or equivalent class of Govt. of India / C.P.W.D. /central undertaking / Railways / M.E.S the proof of registration from the appropriate authority shall be enclosed along with the bid. If successful, the bidder who has not registered under State Government, has to register under the appropriate registering authority of the State Government of Odisha in appropriate class of eligibility before award of the work as per prevalent registration norm of the State Government.


04. Bids must be accompanied by Earnest Money Deposit /Bid Security and cost of bid document of the amount specified for the work in the table Col.No.4 & 5 above, pledged in favour of **Secretary, RMC, Kendrapara.**
05. The bid documents will be available in the web site www.tendersorissa.gov.in from 11.00 hours of 19/09/2016 to 17.00 hours of 03/10/2016 for online bidding.
06. The bidder must possess compatible Digital Signature Certificate [DSC] of appropriate class.
07. **Bid shall be received only 'Online' on or before 03/10/2016 up to 17.00 hours.**
08. Bids received online shall be opened at 11.00 hours on 06/10/2016 in the office of the **Sub-Collector, Kendrapara** in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working days failing which the bids will be rejected.
09. After the date and time of receipt of bid is over, the **original bid security and Demand Draft towards cost of bid document shall be submitted in the office of RMC, Kendrapara** on or before date and time of opening of Bids as specified in the table Col.No.4 & 5 above, during the office hours on working days failing which the bid will be rejected.
10. After opening of financial bid, the original documents of successful lowest bidder as per requirement of Detailed Tender Call Notice [DTCN] will be verified at the office of the undersigned within 5 (five) working days of opening of the bid.
11. The cost of bid document in demand draft issued from any Scheduled Commercial Bank in India may be prepared in favour **Secretary, RMC, Kendrapara.**
12. Other details can be seen in the bidding document.
13. The authority will not be held responsible for any technical snag or network failure during on-line bidding.
14. The bidder may ask questions in the e-procurement portal using his/her Digital Signature Certificate [DSC] from 10.00 hours of 19/09/2016 to 17.00 hours of 28/09/2016 related to the tender clarification.
15. **Special Clause:** Additional performance security shall be deposited by the bidder when the bid amount is less the estimated cost put to tender. In such an event the bidder shall deposit the additional performance security to the extent of the differential cost of the bid amount and the estimated cost put to tender along with the bid document in shape of Demand Draft drawn in any scheduled /nationalize bank in favour of RMC, Kendrapara, payable at Kendrapara . failing which the bid will be rejected . The additional performance security in any other form will not be accepted . No undertaking in this regard will be entertained.
16. The authority reserves the right to cancel any or all the bids without assigning any reason there-of.
